COUNTING CARS

The Strawberry Hill traffic survey undertaken in November aroused questions and complaints from householders who felt they had been left out of the questionnaire.

The survey was confined to an area around the station rather than the whole of Strawberry Hill. It also asked general questions about traffic on which many other people felt they should have been consulted.

Responding to queries from SHRA, John Troke, formerly Richmond Council's Senior Engineer for Transport Planning, said that most of the correspondence about transport issues related to Waldegrave Park, Waldegrave Road, Strawberry Vale and Wellesley Road.

Study scope

These four road were included and the boundary of the South Twickenham Ward was used as the southern and western edges of the study area.

Mr Troke wrote to SHRA: "It was decided that the existing South Twickenham CPZ would not be included. This includes roads such as Radnor Road and Popes Grove. It would not be feasible to consult all of Strawberry Hill so it was decided that it would benefit more local residents if they study on the local centre, namely Wellesley Road."

Mr Troke added that about 1600 addresses were consulted. New schemes would only be introduced after consultation with residents. The study would only be used as an indication of local public opinion.

BIN FINES

Overflowing rubbish bins resulting from people dumping domestic waste in them is a constant source of concern.

Now, Malcolm Sharpe from Richmond Council's Environmental department, and his team of environmental officers, are on the look out for offenders. Elsewhere in the Borough several offenders who have been identified dumping domestic rubbish have been prosecuted and fined heavily.

Shop bins

At SHRA's request, Mr Sharpe has surveyed bin use in Strawberry Hill. He plans to install two extra bins in the shopping area of Strawberry Hill - probably in late April. One will be sited near the Chemist, making two bins in Wellesley Road; an extra bin will be placed outside the shops in Tower Road. The old style bin outside St James's Hall will be replaced with a post box style bin.

CLEANER STREETS?

Residents' views on the state of street cleaning are sought. There is some evidence that since Service-team, the new contractor, took over the cleanliness of roads in Strawberry Hill has improved.

Serviceteam has given us their street cleaning rota for Strawberry Hill. Residents who wish to know when their roads will be swept should contact Clare Phelps.

WILLOW MEMORIAL

Following advice from David Partridge, Richmond Council's Trees Officer, SHRA will fund the replacing of two majestic willows on the river front in Radnor Gardens.

These will replace the planned memorial oak which was to be planted to commemorate Her Majesty's Golden Jubilee. The turf at the old site was turned by The Mayor on Music Day.

The willows, a traditional part of the Thameside, will complete the avenue on the river front and will be planted by Council gardeners this Spring.

A meeting with David Partridge was held in Radnor Gardens in January, at which both SHRA and Friends of Radnor Gardens were present, to discuss ways of keeping the gardens in good condition, preventing damage and dealing with graffiti on the gazebo and summer house.

A DIFFERENT KIND OF GARDEN PARTY

A garden party with a difference – that is, a party to do gardening at Radnor Gardens in April - is being planned.

The date is April 12 and the plan is to tidy the rockery; the time: 10am; venue: the gazebo.

Enthusiasm is more necessary than gardening skills, but trowels and hand forks are essential. Cuttings such as Cistus Rock Rose, Aubretia, perennial Candy Tuft, Bergenia Cordifolia, or any hardy rock plants – i.e tough survivors – will be welcomed.

CAROL SERVICE

The year-end carol service at Holy Trinity Church in December was a departure from the usual joint Friends of Radnor Gardens and SHRA event.

The service of lessons and carols was conducted by The Rev Michael Starkey with superb singing by the church choir.

Mulled wine and mince pies completed the evening.

Planning Matters

METROPOLITAN OPEN LAND

The framework of land use in Britain is largely provided by the town and country planning system under which local authorities are obliged to prepare plans for land use in their areas. For the purposes of protecting wildlife and the natural environment, some land will be designated Metropolitan Open Land.

This has similar status to Green Belt Land. The local authority is obliged to protect and conserve it by keeping it in predominantly open use for as far as can be seen ahead. A good example of Metropolitan Open Land in Strawberry Hill is the Wellesley Road playing field.

As part of the review of land use in the Borough, the Council propose to reconsider the status of certain sites that are currently designated Metropolitan Open Land and to redesignate them to allowing building.

None of the sites under threat are in Strawberry Hill, but in future the might be. Changes in status of these sites under threat will affect the character of the Borough as a whole and should be the concern of everyone.

SHRA is opposed to the proposals in principle and has lodged a complaint. This is partly to ensure that we are notified of any intention to reassess the status of Metropolitan Open Land in our area.

POOLSI DE RENEWAL

SHRA is represented on the TS Riverside Steering Group which is submitting ideas for the second stage of the development of the Twickenham Pool site.

The second stage plan should be ready for consideration by Richmond Council in June next year.

Meanwhile, the first stage of the revised pool plan will see the old pool building replaced with a short term scheme featuring a raised walkway with seats, two childrens play areas and steps from the embankment to give access. The pool area will be fenced off and scheme enhanced with soft and hard landscaping

A longer term scheme foresees the development of a public piazza with a mix of residential, retail and cafe/restaurants.

A public building, such as a viewing tower or river museum, is also being considered.

Both stages will go through normal planning procedures. Stage one should be completed by end March 2004

GRANGE AVENUE SUCCUMBS

After two years resistance, residents opposed to the development in Grand Avenue have been disappointed. The planning application for the demolition of two bungalows and construction of five town houses and a block of six flats has been approved by the Planning Inspectorate following a hearing at York House in November.

SHRA supported the residents, and Robin Walters, who follows planning matters for SHRA, spoke at the hearing.

The principal objections was that the development would generate significant extra traffic flow that would have to pass up and down the whole length of the road. Grange Avenue is a cul-de-sac crowded with houses; the open wooded site provided relief.

The appeal was allowed and, under a S.106 agreement, the Council is to receive £15,268 in respect of education provision and £4,000 for highway improvements.



Five houses and six flats to be built here.

COLLEGE RADIO MAST

SHRA received several complaints from residents concerned about plans to install a mobile telephone radio mast on the science block at St Mary's College. SHRA took up these concerns; however, the mast is now in place.
