## MINUTES OF THE STRAWBERRY HILL RESIDENTS' ASSOCIATION COMMITTEE MEETING, HELD ON WEDNESDAY, 6 NOVEMBER 2019

- 1. Apologies for absence: Peter Lamb, Siobhan Oktay, Cllr Richard Bennett
- 2. Minutes of the last meeting: agreed and David signed a copy.
- 3. Matters arising: None.
- **4. SMU liaison group:** A meeting held last week followed the standard agenda. Mike said that two other meetings had been held to deal with complaints, including issues raised by residents in Clive Road. The relocation of CCTV cameras and the possibility of noise barriers were discussed. Suggestions such as sending a message to students from the Vice-chancellor reminding them of the residential nature of the area will be considered. Re the Master Plan, there has been no change. Upgrading of existing buildings including those in Waldegrave Park is the priority. Offices have been acquired in Regal House and student lectures are being held in the Exchange. Governing Body minutes are still not being posted on the SMU website despite publication being a requirement under model standards for universities. Mike has issued a request under the Freedom of Information Act and will continue to pursue this.
- **5. Councillors' update:** Cllr Butlin said that an order had now been raised for a replacement fence at the re-cycling site on Pope's Avenue. June asked about use of the recycling site. It appears is still being used by flat dwellers.

An enforcement notice has been served on Rochester House but work needs to be done before the bins can be moved from the Strawberry Hill footpath.

Jeremy commented on the Community Conversation saying that only 19 residents attended. Andrew asked Cllr Butlin if there was any guidance of the amount that would be available for devolved Ward budgets. Nothing has been fixed yet but suggestions for spending priorities were welcome.

- **6. Christmas event 13 December**: Arrangements were discussed and Pam will circulate an updated list. Andrew had been given an alternative quote for supply etc of a Christmas tree that was significantly higher than our existing supplier. Teresa agreed to contact Bruce at Crusader Travel for details of their tree supplier.
- **7. Planning:** Mike Allsop reported that the Ajanta development at Pope's Avenue was still under review. He said the application for a large extension at 29 Pope's Grove, a building of townscape merit is still being assessed.
- **8. Bulletin 171:** Julia circulated the draft and it was agreed that this is a very good issue. Julia said that we need to find someone with the skills to take on the design and layout as the current costs are unsustainable. That would also be the time to seek to reduce print costs.
- **9. Bulletin advertising:** Julia said we need to find a couple more advertisers.
